Criminal Law / Mock Trial is a class for students interested in the legal system, court procedures, and understanding law in everyday life, as well as developing public speaking and critical thinking skills necessary for conducting a Mock Trial. Using the popular "Street Law" curriculum and Mock Trial case materials developed by the Constitutional Rights Foundation, students will learn about the American legal system through traditional study and by preparing and participating in an in-class criminal Mock Trial. Participation on River City's Mock Trial competition team is NOT required.

Develop a practical understanding of law and the legal system that will be of use to students in their everyday lives.

- Understand the fundamental principles and values underlying our Constitution, laws, and legal system.
- Develop a greater sense of justice, tolerance, and fairness.
- Understand the need for effective citizen participation in our legal system.
- Improve critical thinking, reasoning, communication, observation, and problem-solving skills through participation in mock trials.
